

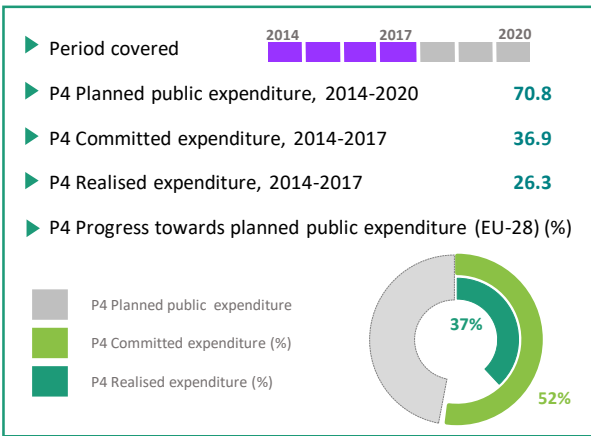
This factsheet contains monitoring data aggregated at EU level (EU-28), providing a comprehensive overview of the state of play in the implementation of the rural development Priority 4 (P4) 'Restoring, preserving and enhancing ecosystems related to agriculture and forestry'. In particular, Section 1 presents financial expenditure¹ aggregated at EU level and broken down by Member State (MS), covering the period between 2014 and end 2017. Section 2 presents the progress realised towards the EU common target indicators linked to P4.

1. Financial expenditure (RD Priority 4)

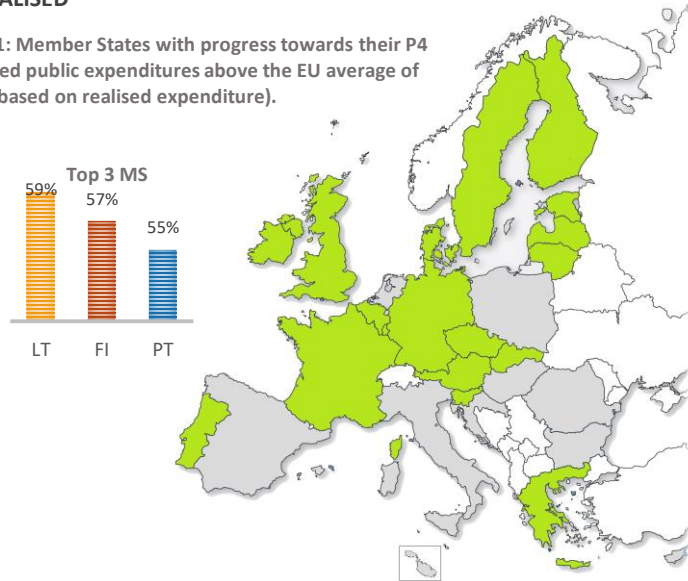

Table 1: Overview of financial expenditure for P4 at EU level (EU-28) - Billion EUR.



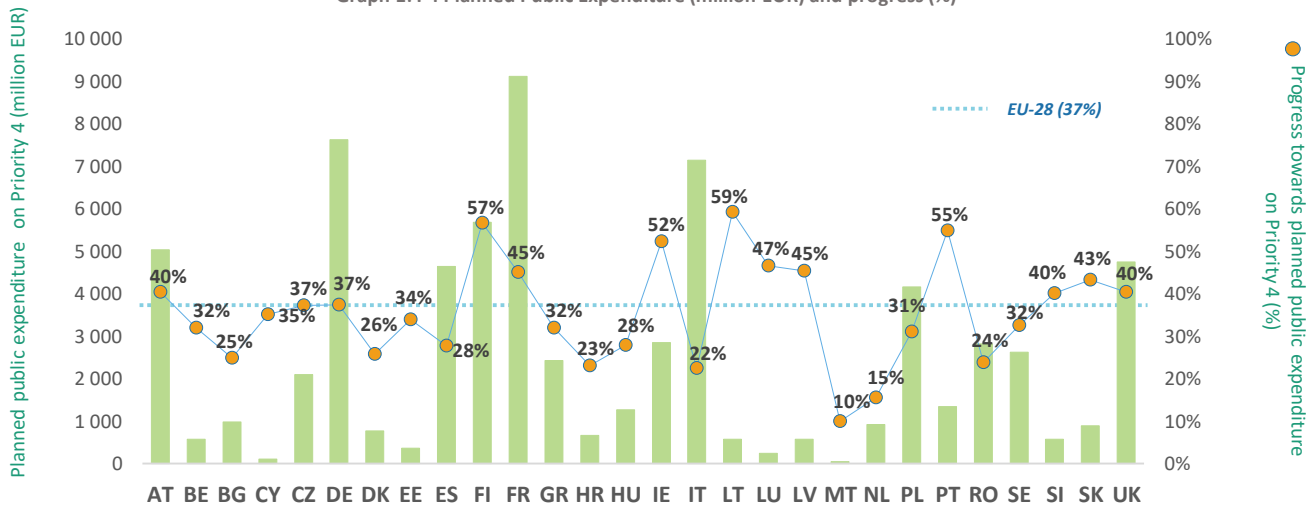
Map 1: Member States with progress towards their P4 planned public expenditures above the EU average of 37% (based on realised expenditure).
